## BIBLE READINGS Acts 8, 26-end

Then an angel of the Lord said to Philip, 'Get up and go towards the south to the road that goes down from Jerusalem to Gaza.' (This is a wilderness road.) So he got up and went. Now there was an Ethiopian eunuch, a court official of the Candace, queen of the Ethiopians, in charge of her entire treasury. He had come to Jerusalem to worship and was returning home; seated in his chariot, he was reading the prophet Isaiah. Then the Spirit said to Philip, 'Go over to this chariot and join it.' So Philip ran up to it and heard him reading the prophet Isaiah, He asked, 'Do you understand what you are reading?' He replied, 'How can I, unless someone guides me?' And he invited Philip to get in and sit beside him. Now the passage of the scripture that he was reading was this: Like a sheep he was led to the slaughter, and like a lamb silent before its shearer, so he does not open his mouth. In his humiliation justice was denied him. Who can describe his generation? For his life is taken away from the earth.' The eunuch asked Philip, 'About whom, may I ask you, does the prophet say this, about himself or about someone else?' Then Philip began to speak, and starting with this scripture, he proclaimed to him the good news about Jesus. As they were going along the road, they came to some water; and the eunuch said, 'Look, here is water! What is to prevent me from being baptized?' He commanded the chariot to stop, and both of them, Philip and the eunuch, went down into the water, and Philip baptized him. When they came up out of the water, the Spirit of the Lord snatched Philip away; the eunuch saw him no more, and went on his way rejoicing. But Philip found himself at Azotus, and as he was passing through the region, he proclaimed the good news to all the towns until he came to Caesarea.

#### NEW TESTAMENT 1 John 4. 7-end

Beloved, let us love one another, because love is from God; everyone who loves is born of God and knows God. Whoever does not love does not know God, for God is love. God's love was revealed among us in this way: God sent his only Son into the world so that we might live through him. In this is love, not that we loved God but that he loved us and sent his Son to be the atoning sacrifice for our sins. Beloved, since God loved us so much, we also ought to love one another. No one has ever seen God; if we love one another, God lives in us, and his love is perfected in us.By this we know that we abide in him and he in us, because he has given us of his Spirit. And we have seen and do testify that the Father has sent his Son as the Saviour of the world. God abides in those who confess that Jesus is the Son of God, and they abide in God. So we have known and believe the love that God has for us. God is love, and those who abide in love abide in God, and God abides in them. Love has been perfected among us in this: that we may have boldness on the day of judgement, because as he is, so are we in this world. There is no fear in love, but perfect love casts out fear; for fear has to do with punishment, and whoever fears has not reached perfection in love. We love because he first loved us. Those who say, 'I love God', and hate their brothers or sisters, are liars; for those who do not love a brother or sister whom they have seen, cannot love God whom they have not seen. The commandment we have from him is this: those who love God must love their brothers and sisters also.

#### GOSPEL John 15, 1-8

'I am the true vine, and my Father is the vine-grower. He removes every branch in me that bears no fruit. Every branch that bears fruit he prunes to make it bear more fruit. You have already been cleansed by the word that I have spoken to you. Abide in me as I abide in you. Just as the branch cannot bear fruit by itself unless it abides in the vine, neither can you unless you abide in me. I am the vine, you are the branches. Those who abide in me and I in them bear much fruit, because apart from me you can do nothing. Whoever does not abide in me is thrown away like a branch and withers; such branches are gathered, thrown into the fire, and burned. If you abide in me, and my words abide in you, ask for whatever you wish, and it will be done for you. My Father is glorified by this, that you bear much fruit and become my disciples.

Almighty God, who through your only-begotten Son Jesus Christ have overcome death and opened to us the gate of everlasting life: grant that, as by your grace going before us you put into our minds good desires, so by your continual help we may bring them to good effect; through Jesus Christ our risen Lord, who is alive and reigns with you, in the unity of the Holy Spirit, one God, now and for ever.

#### Notes

- 1 Every lay person whose name is entered on the Church Electoral Roll of the parish (and no other person) is entitled to vote at the election of parochial representatives of the laity.
- 2 A person is qualified to be elected a parochial representative of the laity if –
- (a) his or her name is entered on the Church Electoral Roll of the parish and, unless he or is under 18, has been entered there for at least the preceding six months;
- (b) he or she is an actual communicant (which means that he has received Communion according to the use of the Church of England or of a Church in communion with the Church of England at least three times during the twelve months preceding the date of the election);

- (c) he or she is at least 16; and
- (d) he or she is not disqualified as referred to in paragraph 3 of these Notes.
- 3 (1) A person is disqualified from being nominated, chosen or elected or from serving as a churchwarden or a member of a parochial church council, a district church council or a joint council if the person is disqualified from being a trustee of a charity (and the disqualification is not subject to a waiver which permits membership of a parochial church council, district church council or joint council).
- (2) A person is disqualified from being nominated, chosen or elected or from serving as a member of a parochial church council, a district church council, a joint council or a deanery synod if the person is included in a barred list (within the meaning of the Safeguarding Vulnerable Groups Act 2006).
- (3) A person is disqualified from being nominated, chosen or elected or from serving as a member of a parochial church council, a district church council, a joint council or a deanery synod if the person has been convicted of an offence mentioned in Schedule 1 to the Children and Young Persons Act 1933 (with that expression being construed in accordance with Rule 71(2) of the Church Representation Rules).
- (4) A person's disqualification under sub-paragraph (3) may be waived by the bishop of the diocese by giving the person notice in writing.
- (5) A person is disqualified from being nominated, chosen or elected or from serving as a member of a parochial church council if the person has been disqualified from holding office under section 10(6) of the Incumbent (Vacation of Benefices) Measure 1977.
- 43 A scheme is in operation in this parish which provides that any person entitled to vote in the elections of parochial representatives of the laity to the parochial church council or to the deanery synod or to both may apply on the appropriate form to the Minister of the parish (or other person signing below) for a postal vote. The completed form must be received before the commencement of the annual parochial church meeting.

#### Notes

- 1 To be included in a year in which parochial representatives of the laity are to be elected to the Deanery Synod.
- $\underline{2}$  To be included in a year when a new Church Electoral Roll is prepared. Delete as applicable.
- 3 This paragraph should be deleted if no scheme for postal voting is in operation in the parish.
- $\underline{4}$  Or vice-chair of the parochial church council as the case may be (see  $\underline{\text{rule M19}(2)}$  of the Church Representation Rules).

# **Community Champions News 29.04.21** Figures

Cases in Solihull have continued to fall to 21.3 per 100,000. This is the result of the lock-down and the vaccination rollout. We are now reaching a plateau figure around which cases will rumble for a while. There will be odd, isolated outbreaks. The virus is less active in the Summer so, hopefully, that will have an impact as well.

#### **Vaccinations**

The rollout is still progressing well. We have to remember that the 18 to 40 age group has not been vaccinated and this is the group that is spreading the virus.

Vaccinations are making a huge difference; there have been no new cases in care homes. If you are coming up to 12 weeks since your first vaccination and do not want to wait to be called for your second, you can book to go to a mass vaccination centre. There is no reduction in efficacy if you go over the 12 weeks.

There have been one or two reports of nose bleeds after a vaccination; these and other adverse reactions to the vaccine may be reported to the Yellow Card scheme; it can be found at:

## **Testing**

Positive test results are now very rare but it is recommended that <u>everyone</u> over the age of 18 gets into the routine of doing a lateral flow test twice a week.

If the LFT is positive, you need to get this confirmed by a PCR test because there has been a small number of false positives; these are available at Tudor Grange Leisure Centre. Details on the above link.

If you collect testing kits from a pharmacy, they may ask you for information; this is to avoid people stockpiling from several places.

New tests are coming through all the time e.g. nostril only tests, and other are being trialled.

#### Other News

GPs are trying to get back to 'business as usual'. Most surgeries now have facilities to send symptoms by text message, and there are telephone triage and appointment arrangements.

After 21st June, we will still need to wear masks and keep up with social distancing.

## **Stronger Communities Solihull**

We heard from Austin Rodriguez, Head of Stronger Communities for SMBC. This department supports collective community action, especially by developing the voluntary sector. They are interested to hear how we can build on the partnerships and community groups built up during Covid, after lockdown restrictions are lifted and life returns to 'normality'. The areas they particularly want to focus on are:

Exploitation, abuse, modern slavery and trafficking.

Climate change and sustainability.

Community Spaces (where people meet up).

Promoting good health and wellbeing.
